OUTSTANDING CONTRIBUTION TO THE CRIMINAL DEFENSE BAR AWARD

MALVINA NATHANSON, ESQ.

Malvina spent most of her 37+ years of practice in the public sector as a criminal defense appellate practitioner and has concentrated on criminal appeals since she opened her own office — although her checkered resume also includes a too-long stint (18 months) with the Queens County District Attorney's Office as head of the Appeals Bureau and a too-short stint (4 months) as a G.O. (*gentil organizeur*) with Club Med and a thankless tenure as Administrator of the Assigned Counsel Plan for Brooklyn, Queens and Staten Island. When she is not trying to get criminals out of jail she devotes many hours to NYSACDL and other bar associations. She has been Amicus Chair, Editor of *The Mouthpiece*, Secretary, Board member, *amicus* author and CLE lecturer for NYSACDL. She is a member of the Executive Committee of the Criminal Justice Section of the New York State Bar Association and has worked on its efforts to increase 18-B fees and reform the Rockefeller Drug Laws. She was just appointed to the State Bar's Special Committee to Ensure Quality of Mandated Representation, which will review the mechanisms for assignment of counsel to indigent criminal defendants throughout the state. She is active in the Criminal Justice Section of the New York County Lawyers' Association and was a member of the Indigent Task Force of that organization. With her remaining time she tries to improve representation for poor civil litigants and is a member of the State Bar's President's Committee on Access to Justice, on the Board (and Executive Committee) of Legal Services for New York, a volunteer lawyer with the Brooklyn Bar Association's pro bono project, and a Small Claims Court volunteer arbitrator. She obviously does not have a life.

EDWARD HAMMOCK, ESQ.

Edward R. Hammock is in private practice in Flushing, where he specializes in criminal defense and post-conviction advocacy. The former Chair of the New York State Board of Parole, Hammock served as Chief Executive Office of the New York State Division of Parole; Executive Director of Daytop Village, Inc., the therapeutic treatment center for the addicted; Deputy Commission of the New York City Department of Investigation; Special Assistant Attorney General for the State of New York Department of Law on the Attica Investigation; Special Assistant District Attorney in Queens, and Assistant District Attorney (Homicide) in New York County.

The former President of the National Association of Paroling Authorities, Mr. Hammock is a former member of the Board of Directors of Addiction Research and Treatment Corporation; Member of the Professional Assistance Program of the New York State Education Department; Chairman of the Board of Directors of the Martin Luther King, Jr. Institute for Non-Violence; and former Chairman of the Board of Directors of the Project Return Foundation, Inc.

He is a member of the Executive Committee of the Criminal Justice Section of the New York State Bar Association and has served the New York State Association of Criminal Defense Lawyers as a Director, and is Chair of the Association's Correctional Issues Committee.



WILLIAM BRENNAN AWARD
FOR OUTSTANDING JURIST

HONORABLE JEFFREY M. ATLAS



Honorable Jeffrey M. Atlas is an Acting Justice of the Supreme Court of the State of New York, New York County where he has served as Presiding Judge at high profile criminal trials since 1982, and has served as Judge of the Criminal Court of the City of New York since 1980. Currently Judge Atlas serves as one of the Judges designated to preside over capital cases and special prosecutions, and for many years served as Presiding Judge in calendar parts of the court, with responsibility for pre-trial proceedings and disposition of felony cases, including supervision of Grand Jury proceedings and the hearing of Constitutional applications.

Before going into the private practice of law in New York City, he served as a Special District Attorney of New York County and Special Assistant Attorney General, he served as Law Clerk to the Hon. Charles M. Metzner, United States District Judge for the Southern District of New York.

A graduate of Syracuse University and Fordham University School of Law, Judge Atlas is a Lecturer-in-Law at Columbia Law School, at trial advocacy programs at Brooklyn Law School, Cardozo Law School, Fordham Law School, Hofstra Law School, New York Law School, New York University Law School, the New York County District Attorney's Office, the Legal Aid Society of New York, and the Assigned Counsel Program in the First Judicial Department.

In addition, Judge Atlas served as Past-President of the Criminal Court Judge's Association, Chair of the Association's Education Committee and member of the Committee on Legislation; Past-Chair of the Personnel Committee of the Supreme Court, First Judicial District; and Member of the Anti-Bias Committee of the Supreme Court, First Judicial District. He was Chair of the Criminal Justice Section of the New York County Lawyers Association.



THURGOOD MARSHALL AWARD FOR OUTSTANDING PRACTITIONER

NEW YORK STATE CAPITAL DEFENDER KEVIN M. DOYLE

Kevin M. Doyle is a graduate of Fordham College and Virginia Law School. After representing indigent defendants at the New York Legal Aid Society, Criminal Defense Division and the Federal Defenders Unit, he joined a Wall Street law firm as an Associate, where he represented a death row inmate in Alabama pro bono.

Doyle joined the Alabama Capital Representation Resource Center where he represented death row inmates and capital defendants in post-conviction, on direct appeal, and at trial, and in July of 1995, was named Capital Defender of New York State's Capital Defender Office, the statewide guarantor of constitutionally-sound representation in capital, and potentially capital, cases.

NEW YORK STATE CAPITAL DEFENDER OFFICE

The Capital Defender Office was born weeks before New York's new statute went into full lethal effect. Back then it was predicted that death row would soon become a place that housed scores and scores of condemned prisoners.

However, owing to the women and men, lawyers and non-lawyers, at the Capital Defender Office and owing to their great, generous allies in the private and institutional defense bar, things have turned out quite differently. Though capital counsel has been assigned to over 800 cases throughout the state, the prosecution learned quickly of the fight they'd be up against and has only sought death fifty times. And, of course, they have won it in only a fraction of those cases.

Today there are five people on death row; and with the help of God and a politically unintimidated Court of Appeals none of those men will be killed.

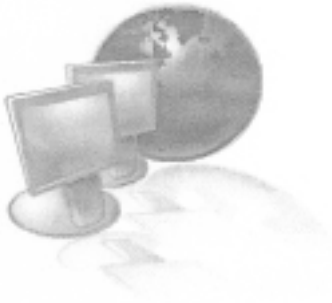
